Where is Huadian Power based?

It generates hydropower, wind power, biomass, and solar electric power. The company was founded on June 28, 1994 and is headquartered in Beijing, China. Huadian Power International Corp. Ltd. engages in the construction and operation of power plants.

Who owns Huadian Power Generation Company Limited?

On 1 July 2021, the Group has completed the acquisition of 48.98%, 70% and 100% equity interests in Hunan Huadian Changde Power Generation Company Limited, Hunan Huadian Changsha Power Generation Company Limited, and Hunan Huadian Pingjiang Power Generation Company Limited (together the "Hunan Area Companies") respectively held by China Huadian.

What does Huadian Power do?

Huadian Power International Corp. Ltd. engages in the construction and operation of power plants. Its business activities include power generation, heating supplies, and sale of coal products. It generates hydropower, wind power, biomass, and solar electric power. The company was founded on June 28, 1994 and is headquartered in Beijing, China.

Where is Huadian Power International Corporation Limited located?

Huadian Power International Corporation Limited (the "Company") was established in Shandong province of the People's Republic of China (the "PRC") on 28 June 1994 as a joint stock limited company and the office address is No. 2 Xuanwumennei Street, Xicheng District, Beijing, the PRC.

What percentage of Huadian wind power is retained?

The Group retained 38.13% in Hebei Huadian Guyuan Wind Power Company Limited. Hence, it becomes an associate of the Group on the same date upon completion of the disposal. The Group retained 36.07% in Huadian Power International Ningxia New Energy Power Company Limited.

How many kilowatt-hours does Huadian Power produce?

The project, operated and constructed by China Huadian Corp., one of the country's major State-owned power companies, has produced more than 8.4 billion kilowatt-hours of clean power since its first unit was put into operation in September 2013.

China Huadian Corporation (Huadian Group;) is one of the five largest state-owned power generation enterprises in China, administered by SASAC for the State Council. It engages in the generation and supply of electricity and heat, and the development of power-related primary energy. It produces about 10% of China's power along with Huaneng Group, Datang Group, SPIC and China Energy.

Huadian Power International Corporation, formerly Shandong International Power Development Company Limited, is the largest power producer in Shandong Province, China, and is the Hong Kong listed subsidiary of China Huadian, one of the five largest power producers in China. The parent company produces about 10% of China's power, and the subsidiary produces approximately another 5%.
